**ADMINISTRATIVE LAW JUDGE'S RULING
DIRECTING WORKSHOP REPORT**

On January 21 and 22, 2025, Energy Division hosted a hybrid *Building Decarbonization Best Practices and Future Pathways Workshop* (Workshop) to discuss lessons learned, best practices and forward-looking strategies from prior and ongoing building decarbonization programs and activities, as well as discussing long-term vision for scaling decarbonization including zonal decarbonization, technology applications, funding, and policy strategies.

This ruling directs Pacific Gas and Electric Company (PG&E) to file and serve a Workshop report by Monday, March 2, 2026, in this proceeding. The report shall contain:
