Mid-day on February 11, 2026, PG&E requested an extension of the deadline set for parties to provide materials relied upon for presentation at the February 20, 2026 all-party workshop. This deadline was set to one week prior to the workshop by Assigned Commissioner Ruling on November 3, 2025 and reiterated by the February 6, 2026 Assigned Commissioner and Administrative Law Judges' ruling.

PG&E, acting on behalf of the joint IOUs and in consultation with the responsive parties, communicated that there is a compromise position that an extension should be requested through February 17, 2026 in consideration of the President's day holiday. As PG&E's Rule 11.6 good-faith effort was conducted yesterday, I find it reasonable to allow any parties that were nonresponsive to that effort an additional period to express their position.

Any party not listed in PG&E's February 11, 2026 extension request may serve their response to this request, but must do so prior to the close of business today.

Dear Administrative Law Judges Chang and Regnier:

Pursuant to CPUC Rule 11.6, Pacific Gas and Electric Company (PG&E), San Diego Gas and Electric Company (SDG&E), and Southern California Edison (SCE) (jointly, the "IOUs") respectfully request an extension of the deadline for when parties are required to serve Party Presentation Materials (Materials) as determined in the *Assigned Commissioner's and Administrative Law Judges' Ruling providing All-Party Workshop Information and Schedule Modification* (Ruling), filed Feb. 6, 2026.

The list of topics to be required in the Materials as outlined in the Ruling is robust, and the IOUs will require more time to compile the information requested. Therefore, with the President's Day holiday weekend in mind, the IOUs request an extension of the service date of the Materials from Feb. 13, 2026 to February 17, 2026.

Pursuant to Rule 11.6, PG&E reached out to parties to this proceeding on Feb. 10, 2026, asking whether they support, oppose, or take no position to the request for extension. Via this communication, parties conversed and reached a compromise of Feb. 17 as the deadline for this extension request. All parties that responded indicated that they are in support of the extension, including: the Public Advocates Office (Cal Advocates); Utility Consumers' Action Network (UCAN); the California Community Choice Association (CalCCA); and, MCE Community Choice Energy (MCE).

The IOUs do not believe that this extension request would prejudice any party and therefore request that the Commission grant this extension. Given the impending deadline of Feb. 13 wherein the Materials are currently required to be served to parties, the IOUs respectfully request that the Commission expedite its review and approval of this extension request.
