**Subject:** R.25-10-003 E-mail Ruling Modifying Track 1 Schedule

To All Parties:

The Assigned Commissioner's Scoping Memo and Ruling (Scoping Memo), issued on December 12, 2025, established the following Track 1 schedule.

As provided in the Scoping Memo, the proceeding schedule may be modified as necessary by the assigned Commissioner or Administrative Law Judge to promote efficient management and fair resolution of this proceeding.

Due to unforeseen issues in preparing Energy Division's Report on Transactability Issues, Energy Division's Report was not issued on February 6 and is further delayed. Energy Division's Report is now expected to be issued in approximately two weeks. Once Energy Division's Report is issued, a ruling will be issued that modifies the dates set for "Transactability Issues" in the Track 1 schedule so that parties have an opportunity to review and comment on Energy Division's Report.

As such, the dates set for "Transactability Issues" in the Track 1 schedule are suspended until a subsequent ruling is issued. All other Track 1 dates remain unchanged. Despite the delay in the schedule, the Commission expects to consider the "Transactability Issues" topic and proposals in Track 1 of this proceeding. Accordingly, the Track 1 schedule is modified as set forth below.
