**ADMINISTRATIVE LAW JUDGE RULING ON EXHIBIT MOTIONS**

This ruling grants a Joint Motion to Enter Testimony into the Record, as well as motions by Pacific Gas and Electric Company and The Utility Reform Network related to exhibits.

**1. Procedural and Factual Background**

On June 27, 2025, San Diego Gas & Electric Company (SDG&E) and Southern California Gas Company (SoCalGas) filed their respective applications requesting approval and funding for their Income Qualified Assistance Programs portfolios for Bridge Year 2027. Southern California Edison Company (SCE) and Pacific Gas and Electric Company (PG&E) filed their respective applications on June 30, 2025. An Administrative Law Judge (ALJ) ruling on July 25, 2025, consolidated the proceedings and set a date of August 18, 2025 for the prehearing conference (PHC).

Protests were filed on July 31, 2025, by the Commission's Public Advocates Office (Cal Advocates) and The Utility Reform Network (TURN). Responses were filed on the same date by the Energy Efficiency Council, Maravilla Foundation and The East Los Angeles Community Union, and Center for Accessible Technology (CforAT).

These applications are intended to be a temporary one-year stopgap to ensure continuity for the California Alternate Rates for Energy (CARE), Family Electric Rate Assistance (FERA), and Energy Savings Assistance (ESA) programs.

An ALJ ruling was issued on August 14, 2025, presenting a draft scope and schedule for discussion at the PHC. The PHC was held on August 18, 2025. An ALJ ruling was issued on August 29, 2025, directing PG&E, SDG&E, SCE and SoCalGas (collectively, the Utilities) to submit additional supplemental information as testimony. The Assigned Commissioner's Scoping Memo and Ruling (Scoping Memo) was issued on September 17, 2025, laying out the schedule and scope of this proceeding. On January 14, 2026, a Joint Motion to Admit Testimony into the Evidentiary Record (Joint Motion) was filed by PG&E. On January 16, 2026, PG&E submitted a correction to the Joint Motion, as well as a Motion for Leave to File Under Seal Confidential Workpaper. On February 3, 2026, TURN filed a Motion to Admit Late-Submitted Corrected Exhibit into Evidence.

## **2. Joint Motion to Admit Testimony**

The Joint Motion was presented on behalf of all parties submitting testimony, including PG&E, SDG&E, SCE, SoCalGas, CforAT, the California Emerging Technology Fund (CETF), Cal Advocates, and TURN. Attached to the Joint Motion was a list of exhibits that the parties stipulated to admission into the record. The exhibit that was marked CETF-02, a revised Joint Stipulation, has yet

to be provided, and as such is not entered into the record at this time. No parties protested the Joint Motion. The Joint Motion is granted. The exhibits listed in Attachment A to this ruling, except the exhibit marked CETF-02, are entered into the record.

### **3. Subsequent Motions**

On January 16, 2026, PG&E submitted both a correction to the Joint Motion, as well as a Motion for Leave to File Under Seal Confidential Workpaper. The correction fixed a broken link that was listed for a PG&E Exhibit (PGE-02). The Motion for Leave to File Under Seal related to a workpaper that presented information related to PG&E's ESA Workpaper, titled "IQP\_2027\_WP\_PGE\_20250630\_ESA\_HPWH R\_R BAAQMD Incremental Cost Request\_Pilutti\_CONF", or BAAQMD Incremental Cost Workpaper. No parties protested the Motion, and it is granted.

TURN submitted a Motion to Admit Late-Submitted Corrected Exhibit into Evidence on February 3, 2026. TURN's version of exhibit TURN-01 that was submitted with the Joint Motion inadvertently left out appendices that were attached to the original version of TURN-01 served on November 21 2025. TURN's Motion seeks to enter into evidence a corrected version of TURN-01, with Appendix A and Appendix B attached. TURN noted that it contacted all parties and did not receive objection to the admission of the new revised exhibit TURN-01A. TURN's Motion is granted.

### **4. Exhibits Entered into Record**

Attachment A to this ruling identifies and receives into evidence all exhibits listed, except the exhibit identified as CETF-02, which shall be received at a later time.

**IT IS RULED that:**

1. The Joint Motion to Admit Testimony of January 14, 2026 is granted.
2. PG&E's Motion to File Under Seal a Confidential Workpaper is granted.
3. TURN's Motion to Admit Late-Submitted Corrected Exhibit is granted.
4. The exhibits marked in Attachment A are entered into the record, except the exhibit marked CETF-02.

This order is effective today.
