I. STATUS UPDATE

The Parties¹ thank Administrative Law Judge (ALJ) Afary for the January 22, 2026, Ruling Granting Motion for Stay of Procedural Schedule Issued November 25, 2025 (Ruling). Consistent with Ordering Paragraph 3 of the Ruling, the Parties provide this brief status update.

Following Pacific Gas and Electric Company’s (PG&E) site visit on January 6, 2026, and receipt of the Ruling on January 22, 2026, the Parties held another settlement conference on January 23, 2026. Since then, the parties have been working to finalize a Settlement Agreement and accompanying Motion for Adoption of Settlement Agreement. Barring unforeseen circumstances, the Parties anticipate filing the Settlement and Motion in March.
