ADMINISTRATIVE LAW JUDGE'S RULING SETTING PREHEARING CONFERENCE

A Prehearing Conference (PHC) is set in this matter for March 13, 2026, starting at 11 a.m. A PHC is called to (1) determine the parties; (2) accept appearances and establish the permanent service list; (3) determine the positions of the parties; (4) identify issues for inclusion in the scoping memo for this proceeding; (5) discuss the schedule for this proceeding; (6) determine if there are any challenges to either the categorization of this proceeding or the preliminary determination that there is no need for hearings; and (7) discuss any additional procedural matters relevant to this proceeding.

The PHC will be conducted telephonically. Parties shall appear telephonically by calling 1-866-556-2084, participant code 8423816. Parties are directed to adhere to the following ground rules during the telephonic PHC:

- Mute your phone when not speaking;
- Speak only when addressed by the Administrative Law Judge;
- State your name each time before you speak;
- Speak slowly and clearly;
- Do not use a speaker phone when speaking; and
- Do not interrupt or speak over one another.

Any party that would like an expedited transcript of the PHC should notify the Chief Hearing Reporter of this by emailing reporting@cpuc.ca.gov no later than three days prior to the PHC.
