The application of The Landline Company, hereinafter referred to as "Applicant", respectfully states:

**I. Applicant Identification.**

The exact name of Applicant is The Landline Company, a corporation formed under the laws of Delaware. A copy of Applicant's certificate of incorporation filed with the Delaware Secretary of State is attached hereto as **Exhibit A-1**.

Applicant is qualified to conduct business in the state of California pursuant to its statement and designation by foreign corporation filed on July 16, 2018, with the California Secretary of State, as amended by the amendment filed in that office on October 29, 2019, copies of which are attached hereto as **Exhibit A-2**. Also included in **Exhibit A-2** is Applicant certificate of status of a recent date from the California Secretary of State.

### **V. Authority Requested**

Pursuant to Public Utilities Code Section 1031, Applicant requests a Certificate of Public Convenience and Necessity to establish and operate as scheduled passenger stage corporation, for the transportation of passengers between Charles M. Schulz-Sonoma County Airport (STS) and San Francisco International Airport (SFO). The proposed service will consist of direct, airport-to-airport passenger transportation open to the general public. Passenger tickets will be sold directly by Applicant through its reservation channels. Passengers will be able to pre-book seats on scheduled departures operating multiple times per day, subject to demand.

### **VI. Proposed Fares and Rate Structure**

The proposed fares to be assessed for this service, and rules and regulations governing the same, are as set forth in **Exhibit C** attached hereto. Applicant proposes to charge a base fare of \$55 per adult, one-way for scheduled passenger stage corporation service between Charles M. Schulz–Sonoma County Airport (STS) and San Francisco International Airport (SFO).

To keep its fares competitive, pursuant to Public Utilities Code Section 454.2, Applicant requests Commission’s approval to establish a Zone of Rate Freedom (ZORF) of 15% above and below the proposed base fares set forth in **Exhibit C**, with a minimum one-way adult fare of \$46.75, except that notwithstanding the ZORF, children (age 0–11), who must be accompanied by an adult with a purchased adult fare, shall have a fare of \$0. Applicant’s scheduled passenger stage transportation service will operate in competition with other passenger transportation services (including but not limited to taxicabs, transportation network companies, and charter-party carriers), and the authorized ZORF together with such competition will result in reasonable rates and charges for the passenger stage transportation service.

## **VII. Proposed Schedule of Service**

The proposed schedule of service and service description is set forth in **Exhibit D** attached hereto. Service will consist of direct, airport-to-airport passenger transportation open to the general public. Passengers will be able to purchase tickets sold directly by Applicant through its reservation channels. Some tickets may also be offered for sale on an interline basis through Applicant's airline partners, where customers will travel on the issuing airline's ticket. In all cases, Applicant will be clearly identified as the operator of the ground transportation service. Service is performed under the conditions outlined in both **Exhibit C, *Proposed Fare, Rules, and Regulations***, and **Exhibit D, *Schedule of Service & Service Description***.

The proposed service will operate as a scheduled, non-stop, airport-to-airport passenger transportation service between Charles M. Schulz–Sonoma County Airport (STS) and San Francisco International Airport (SFO). Depending on prevailing traffic conditions, time of day, roadway incidents, weather, or other operational considerations, Applicant may utilize one of several established highway routings between STS and SFO in order to maintain schedule reliability and passenger safety.

## **VIII. Route Map**

The specific primary and alternative routings proposed for this service are depicted in **Exhibit E** attached hereto, which illustrates the commonly used freeway corridors that may be utilized. All routings originate at STS and terminate at SFO. There are no intermediate passenger pick-up or drop-off points. The use of alternative routes does not alter the nature or scope of the authority requested herein.

## **IX. Equipment Operated**

A description of the equipment to be operated in the proposed service is set forth in **Exhibit F** attached hereto.

## **X. Financial Fitness**

Applicant's current financial statements are attached hereto as **Exhibit G**.

## **XI. Public Convenience and Necessity**

Public convenience and necessity require the grant of authority requested by Applicant for the following reasons:

- Travel demand between the Sonoma County/North Bay region and the San Francisco Bay Area airport market is substantial and ongoing. Available travel data indicates that approximately 16,000 passengers travel daily between the

North Bay region and Bay Area airports, demonstrating sustained demand for reliable ground transportation in this corridor.

- Applicant's proposed service will introduce a scheduled, non-stop motorcoach transportation option between Charles M. Schulz–Sonoma County Airport (STS) and San Francisco International Airport (SFO), expanding public transportation choices and providing a convenient and reliable alternative to private automobile travel, existing shuttle, and transportation network services.
- The proposed service is designed to offer predictable departure/arrival times, and nonstop airport-to-airport connectivity, characteristics that are not consistently available across all existing ground transportation options.
- The proposed service has the potential to reduce overall travel time for passengers while supporting broader public interests related to regional mobility, traffic congestion, and environmental impact. Each motorcoach trip has the potential to reduce the number of individual vehicles traveling on regional roadways, contributing to reduced congestion, lower per-passenger emissions, and decreased parking demand at airport facilities.

Granting the requested authority will enhance regional mobility, improve access to the region's primary international airport, and serve the public interest by supporting efficient, scheduled ground transportation in a high-demand travel corridor.

In addition, Applicant requests authorization to establish a Zone of Rate Freedom to allow reasonable adjustments to fares in response to competitive conditions, demand patterns, and operating considerations in a corridor that is already served by multiple transportation alternatives. The requested Zone of Rate Freedom, together with the presence of existing transportation options, will promote a price-competitive environment, expand consumer choice, and help ensure that fares remain reasonable while permitting Applicant to make limited adjustments without the need for frequent formal filings with the Commission.


