Subject: A.25-05-009 (PG&E 2027 GRC) E-mail Ruling Clarifying Motion Regarding Confidentiality

Parties to proceeding A.25-05-009:

PG&E requests clarification of the requirement to file a motion to seek confidential treatment of evidence. In this regard, the intent of the March 10, 2026, ruling is for PG&E and any other party seeking confidential treatment of any evidence, including information served in the response to the

February 3, 2026, Joint Ruling Requiring Additional Information, to file such a motion regardless of whether or not the evidence is filed or served.

Given the above intent, PG&E is granted leave to file a motion for confidential treatment by March 27, 2026.

It is so ruled.
