To the Service List for R.24-01-018 (Energization OIR):

On April 7, 2026, the Southern California Tribal Chairmen's Association filed for party status. This motion is granted.

On April 8, 2026, Pacific Gas and Electric Company, Southern California Edison Company, and San Diego Gas & Electric Company (together, the Joint Utilities) requested to deadline extensions for Opening Comments and Reply Comments on the Assigned Commissioner's Amended Phase 2 Scoping Memo and Ruling. The Joint Utilities requested the deadline for opening comments be extended from April 16, 2026 to April 30, 2026, and the deadline for Reply Comments be extended from April 30, 2026, to four weeks after Opening Comments (i.e., May 28, 2026). Their request is granted.
