Dear CPUC,

I'm appealing your decision to fine our company Cosand Partners LLC for \$9,200. I would be grateful if you would consider the following points:

- As Sheela Dawadi mentioned in her introductory email "There have been no complaints regarding this carrier." We have been licensed with the CPUC since July of 2014
- We have always had a policy of doing things according to the laws of our state. We are a smaller company with 8-10 employees. Aside from all client interactions (whom we have a staff for) I as the owner manage everything else.
- In violation of G.O. 157-E, Part 3.04 I feel that Sheela did not explain clearly what this was per our email correspondence. In addition to this, all Sub-Carriers listed on our paperwork (some of whom farm in a lot of business to us) have never provided this form. This form has never been presented (ever) to us from any CA company operating under your authority either on or not on this list who farm in business to us.
- In violation of using carriers that did not hold valid TCP authority I will break this out into the 3 carriers we used
 1. Please see attached documentation for use of State Line Charter who is the same person and same owner as Capital Transportation Services. Included you will find the owner's CA Driver's License front and back, Statement of Information for now defunct Capital Transportation, Statement of Information for State Line Charter LLC. and State Line Charter's Operating Authority Letter. Said Saidy who is a single car operator, was the person/driver who provided the two trips #80477 and #80557. As evidenced by the documentation attached, he was the sole owner of Capital Transportation Services and the current owner of State

Line Charter. This was a case of Said not sharing with me the change in records and me not checking and the company we used is fully licensed and insured.

2. On Time Transportation we used one time in a last-minute situation. They were referred to us by one of our TCP partners and I did not check documentation for the company
 3. I spoke with the owner of SF City Tours. He was overseas for surgery and wasn't present when you sent mail to him about worker's comp issue. Without knowledge of the license being revoked, he continued operating all the way through being reinstated on 02/17/2026 with same TCP #. Please see attached as you accepted SF City Tours funds for Q3 and Q4 fees. The owner didn't know there was a problem until he returned to the States.
- In conclusion, as the owner of a smaller company I do the very best I can to operate above board. All listed violations were "an honest mistake" as is said. Absolutely nothing was done with the intention of saving money or circumventing any laws. Thank you for your time and consideration in this matter.

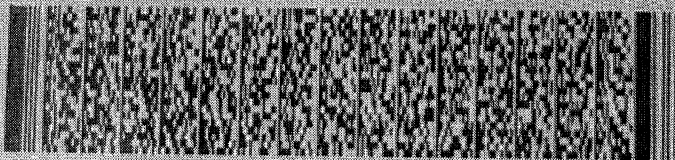

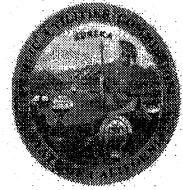

The above-named Carrier, having made written application to the Public Utilities Commission of the State of California for a certificate to operate as a CHARTER-PARTY CARRIER OF PASSENGERS, pursuant to Sections 5351 through 5420 of the Public Utilities Code, is granted this certificate authorizing the transportation of passengers by motor vehicle over the public highways of the State of California as a CHARTER-PARTY CARRIER OF PASSENGERS, as defined in said Code, subject to the following conditions:

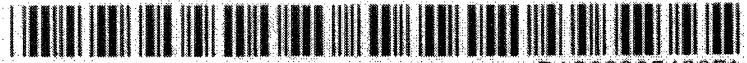
1. This certificate is issued pursuant to Public Utilities Code Section 5383, and said Carrier shall operate from a radius of no more than 125 air miles from the home terminal to any point in the state. This mileage restriction applies only to vehicles seating 10 or fewer, including the driver.
2. No vehicle or vehicles shall be operated by said Carrier unless adequately covered by a public liability and property damage insurance policy or surety bond as required by Public Utilities Code Section 5392.
3. Said Carrier shall comply with all Commission orders, decisions, rules, directions, and requirements governing the operations of said Carrier including General Order Series 115 and 157 and shall remit to the Commission the Transportation Reimbursement Fee required by Public Utilities Code Section 403.
4. All vehicles operated under this certificated authority shall comply with the requirements of the Motor Carrier Safety Section of the California Highway Patrol. No vehicle shall be operated unless it is named in the Carrier's most recent equipment list on file with this Commission. Written amendments to the equipment list shall be filed within ten days of the date the vehicle is put into or pulled out of service.
5. This certificate is subject to amendment, modification, suspension or revocation as provided in the Public Utilities Code and in Commission Resolutions PE-498, PE-501, and TL-18336.
6. This certificate may not be sold, assigned, leased, or otherwise transferred or encumbered without Commission authorization.
7. This certificate does not authorize the Carrier to conduct operations on the property of or into any airport unless such operation is authorized by the airport authority involved.
8. This certificate does not authorize round-trip sightseeing tour service.
9. The use of top lights and/or taxi meters in all vehicles operated under this certificate is prohibited (D. 82-05-069).
10. Relocation of terminal is permitted upon notification to the Commission. However, any relocation and/or addition of terminal outside the 125-air mile limit requires a new certificate and 30-day notice/publication.
11. **This certificate expires 2026-12-31.** It may be renewed every three (3) years upon submission and approval of a renewal application. **This renewal application should be submitted 90-days prior to the expiration date.**
