**Subject:** R.25-10-003\_Email Ruling Modifying Track 1 Schedule for Flexible  
Capacity Requirement Issues

To All Parties:

On April 3, 2026, an Administrative Law Judge’s ruling was issued that adopted the following revised schedule for Flexible Capacity Requirements (FCR) and Local Capacity Requirements (LCR):

Comments on draft 2027 LCR Report filed and served	April 20, 2026
CAISO publishes final 2027 LCR Report	May 1, 2026
Comments on final 2027 LCR Report filed and served	May 8, 2026
Reply comments on final 2027 LCR Report filed and served	May 13, 2026
CAISO publishes final 2027 FCR Report	Early May 2026
Comments and reply comments on final 2027 FCR Report filed and served	Mid-May 2026

On May 1, CAISO filed a Notice of Availability for the Final 2027 Local Capacity Technical Report and notified that CAISO “is targeting a filing date of May 15, 2026” for the Final FCR Report. CAISO stated that it published its draft 2027 FCR Report on March 31, held a stakeholder meeting on April 2, and would file the final 2027 FCR Report as soon as practicable.

If the Final FCR Report is not finalized by May 15, the FCR Report may not be timely incorporated into the upcoming proposed decision, which is expected to issue on May 29. As such, it may be necessary to issue a separate proposed decision on the FCR Report.

To issue a decision on the Final FCR Report as soon as practicable, a shortened comment schedule on the Final FCR Report is adopted. Once CAISO files its Final FCR Report into this proceeding, parties shall have until **the end of the third business day after the day the CAISO files its FCR Report** to file and serve responsive comments.

Accordingly, the schedule for FCR issues is modified below. The schedule for LCR issues remains unchanged and is included below for reference.
