Mr. and Ms. Howe (Complainants) shall file any documentation that they have that indicates there are errors in their billing from 2020 through 2025 from SDGE. Note, I am in receipt of the Complainants' complaint, therefore, there is no need to send me duplicates of what I already have. Please only file documentation that I do not already possess that supports your case.

San Diego Gas and Electric Company (SDGE) shall provide a table with the years 2020 through 2025 and months of January through December. The table will include the amount of electricity used by the Complainants, cost of the electricity (per month), amount paid by the Complainants and any balanced carried over. SDGE will also provide in the table the original copies of the billing statements in tabs in chronological order.

SDGE may file any additional documentation to support its position.

Complainants and SDGE will send their additional documentation to the service list which can be found here.
