Parties to C.25-05-021:

Reply Briefs in this matter were filed on March 6, 2026. On March 30, 2026, Complainant filed a Motion for Expedited Issuance of Decision (Motion). On May 13, 2026, Complainant filed Comments on the Proposed Decision, which refer to the Order Extending Statutory Deadline (OESD) in this matter. The matter has been submitted and the record is closed.

Rule 4.6 governs the Expedited Complaint Procedure for matters in which the amount of money claimed does not exceed the jurisdictional limit of the small claims court as set forth in subdivision (a) of Section [116.220](#) or [Section 116.221 of the Code of Civil Procedure](#). Rule 2.9 discusses Requests for Expedited Schedule in which an application requesting an expedited schedule must do so at the outset of the proceeding, whereby a "Request for Expedited Schedule" is noted in the title page of the application with the details of the request noted in a separate attachment, also entitled "Request for Expedited Schedule". The instant Complaint did not identify a "Request for Expedited Schedule" at the outset of the proceeding, and it was not filed as an Expedited Complaint. As such, the Motion is denied. However, the Commission is aware of the issues and concerns Complainant has raised and is working to ensure the proposed decision is issued as soon as possible.
