**COMPLAINANT’S RESPONSE TO ADMINISTRATIVE
LAW JUDGE’S RULING SETTING ORDER TO SHOW
CAUSE HEARING**

I. INTRODUCTION

Complainant Konkow Partners LLC submits this response to demonstrate that its prior suspension has been resolved, the entity is now active and in good standing, and dismissal is not warranted. As shown by the attached documentation, Complainant has cured the issue identified in the May 5, 2026 ruling. Further, Complainant previously submitted the required revivor paperwork and payments to the California Franchise Tax Board (FTB) in December 2021, and the continued suspension appears to have resulted from an FTB processing or administrative error rather than any failure by Complainant to comply.

II. KONKOW PARTNERS LLC IS NOW ACTIVE AND IN GOOD STANDING

The May 5, 2026 ruling directed Complainant to provide documentation from the California Secretary of State and/or Franchise Tax Board confirming that the suspension has been lifted and that the entity is now in good standing. Complainant has done so. Attached as *Exhibit 1* is the current Secretary of State website record reflecting that Konkow Partners LLC is active and in good standing. Attached as *Exhibit 2* is the Certificate of Revivor issued by the

Franchise Tax Board confirming that the entity's suspension has been lifted and that the entity has been revived.

III. KONKOW PARTNERS LLC PREVIOUSLY SUBMITTED THE REQUIRED REVIVOR MATERIALS AND PAYMENTS TO THE FTB IN DECEMBER 2021

The record also demonstrates that Complainant previously attempted to resolve the suspension in December 2021. On or about December 24, 2021, Complainant submitted correspondence to the Franchise Tax Board explaining the circumstances surrounding the late payments, including the severe impacts of the 2018 Camp Fire, the Bear Fire, the Dixie Fire, and COVID-related disruptions. In that same correspondence, Complainant advised the FTB that it had made the required payments and had completed and included Form 3557 LLC, Application for Certificate of Revivor.

The supporting documents provided in *Exhibit 3* confirm that Complainant submitted the revivor paperwork and payments in December 2021. The Form 3557 LLC was completed and signed on December 23, 2021, requesting relief from suspension or forfeiture. The payment confirmations likewise reflect payments made on December 23 and December 24, 2021.

IV. DISMISSAL IS NOT WARRANTED

Because Complainant is now active and in good standing, the issue identified in the Order to Show Cause (OSC) ruling has been cured. Moreover, the December 2021 revivor documents and payment confirmations demonstrate that Complainant previously submitted the materials necessary to resolve the suspension years before this complaint was filed. To the extent the FTB's records continued to reflect a suspended status after December 2021, that continued status appears to have resulted from an administrative or processing error by the FTB, not from any failure by Complainant to submit the required revivor application or payments.

Under these circumstances, dismissal would not serve the interests of justice. The

purpose of the OSC was to determine whether Complainant's suspended status remained unresolved. Because the suspension has now been lifted and Complainant is in good standing, there is no basis to dismiss the complaint.

V. CONCLUSION

For the foregoing reasons, Complainant respectfully requests that the Commission discharge the Order to Show Cause, take the June 23, 2026 OSC hearing off calendar and permit this proceeding to continue on the merits.

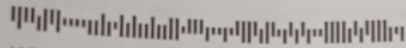
