**Subject:** A.25-05-001: Email Ruling Canceling Evidentiary Hearing and Revising the Procedural Briefing Schedule

To the Service List of A.25-05-001:

This email ruling removes the evidentiary hearing scheduled for Application (A.)25-05-001, Southern California Gas Company's Branch Offices Closure Proposal, which was set for May 26 and May 29, 2026, from the procedural schedule of this proceeding. It also provides updates to the briefing schedule for A.25-05-001.

On May 15, 2026, parties to this proceeding provided notice that they are not requesting evidentiary hearing to resolve A.25-05-001. The parties also agreed the exhibit list provided in Attachment of my May 12, 2026, Administrative Law Judge (ALJ) Ruling fully reflects the evidence that should be admitted in A.25-05-001. The exhibit list titled A2505001 Joint Exhibit List 2026.05.07 Revised is re-attached to this email for reference; no changes have been made.

Pursuant to Rule 9.1 of the Commission's Rules of Practice and Procedure (Rules), I grant the request filed on May 15, 2026, by Utility Workers Union of

America, AFLCIO, Local 132 and International Chemical Workers Union Locals 350c, 478c, and 995c (Unions).

The Unions requested a one-week extension of the current schedule for the proceeding. This extension will provide all parties additional time to draft, file, and serve briefs in A.25-05-001.

Under Rule 13.11, the assigned ALJ may request additional evidence as necessary to resolve any outstanding issue(s) in this proceeding.

IT IS RULED:

1. The evidentiary hearing dates set for May 26 and May 29, 2026, are removed from the procedural schedule of A.25-05-001.
2. Opening Briefs in A.25-05-001 are due May 29, 2026.
3. Reply Briefs in A.25-01-001 are due June 15, 2026.
4. The Joint Exhibit List provided as Attachment A of the May 12, 2026, ALJ Ruling is admitted as evidence in A.25-05-001.

The Docket Office shall formally file this email ruling.
