**SOUTHERN CALIFORNIA EDISON COMPANY’S (U-338E)
CONSENT TO TERMS AND CONDITIONS OF FINANCING ORDER**

Ordering Paragraph 49 of D.26-05-006 (the “Financing Order”)¹ states that “[t]his Financing Order shall become effective in accordance with its terms and conditions only when Southern California Edison Company (SCE) provides its written consent to all terms and conditions of this Financing Order. This Financing Order shall be void and of no force or effect if SCE does not provide its written consent to all terms and conditions of this Financing Order.”² The Financing Order also requires that if SCE consents, it must “file and serve within 10 days from the date the Financing Order is mailed a written statement that . . . SCE consents to all terms and conditions of this Financing Order.”³ The California Public Utilities Code Section 850.1(d) provides “A financing order . . . shall become effective in accordance with its terms

only after the electrical corporation files with the commission the electrical corporation's written consent to all terms and conditions of the financing order.”

Pursuant to the Financing Order and Section 850.1(d) of the California Public Utilities Code, SCE hereby consents to the terms and conditions of the Financing Order. Accordingly, upon the filing of this written consent, the Financing Order is effective.
