On March 5, 2026, San Gabriel Water Company (San Gabriel) filed a motion requesting interim rates. Cal Advocates did not file an objection to San Gabriel's motion.

San Gabriel's motion is granted because additional time is necessary for the Commission to complete its due diligence and analysis of this proceeding.

San Gabriel's motion for interim rates to be effective July 1, 2026, and request to create a memorandum account to track any differences between the interim rates and final rates is approved.

San Gabriel shall file a Tier 1 advice letter to establish the interim rates and memorandum account.
