To all Parties in A.25-07-003,

In light of the Motion for Approval of a Settlement Agreement jointly filed by California American Water company (Cal-Am) and the Public Advocates Office at the California Public Utilities Commission (Cal Advocates) on June 8, 2026, Cal-Am is required to submit the following additional testimony:

“Table showing the original amounts requested by Cal-Am for each cost category or cost center (can use numbers in the results of operations) and the corresponding amounts requested pursuant to the Settlement Agreement. If the information is available, Cal-Am can include the amounts originally proposed by Cal Advocates in order to more easily evaluate the proposed Settlement Agreement.”

Cal-Am shall submit the additional testimony described above by filing a Motion to Admit Additional Testimony within 15 days from the date of this ruling.

Cal-Am shall email the assigned Administrative Law Judge as soon as possible if it has any procedural questions regarding the additional testimony being requested in this ruling.
