**Subject:** Administrative Law Judge's Email Ruling Granting Party Status to CADE (R. 24-06-012)

This email ruling grants the Motion for Party Status filed by the California Alliance for Digital Equity (CADE) on April 24, 2026.

Rule 1.4 addresses participation in Commission proceedings. Pursuant to Rule 1.4 (b), a person seeking party status by motion shall “(1) fully disclose the persons or entities in whose behalf the filing, appearance or motion is made, and the interest of such persons or entities in the proceeding; and (2) state the factual and legal contentions that the person intends to make and show that the contentions will be reasonably pertinent to the issues already presented.” Rule 1.4 (c) states that the assigned Administrative Law Judge may, where circumstances warrant, deny party status or limit the degree to which a party may participate in the proceeding.

CADE states that it is a coalition of more than twenty community-based, non-profit, and philanthropic organizations committed to advancing digital equity and improving connectivity across California. CADE states that it intends to provide comments on ways to uphold California’s obligation to universal access in a manner that protects the interests of vulnerable consumers living in rural, underserved, and/or historically disadvantaged communities. CADE’s motion meets the requirements of Rule 1.4 (b).

Therefore, IT IS RULED, the motion filed by CADE is granted. CADE is granted party status.
