**Subject:** C.25-12-024 Muniz v. Charter / Spectrum Ruling Requiring Evidence

To all Parties:

Mr. Muniz shall file any documentation that he has that indicates that there are errors in his billing from 2025 to 2026. Note, I am in receipt of Mr. Muniz's complaint and corresponding documents, therefore, there is no need to send me duplicates of what I already have. Please only file documentation that I do not already possess that supports your case.

Charter / Spectrum shall provide a table with the years 2025 through 2026 and months January through December. The table shall include the services provided to Mr. Muniz, the cost of each service, the length of the cost of service (if a promotional plan), the amount paid by Mr. Muniz, the final date of the promotional plan, and any balance carried over. Charter / Spectrum will also provide in the table the original copies of the billing's statements in tabs in chronological order. In addition, Charter / Spectrum will provide information about all the senior programs that Mr. Muniz qualifies for from 2024 to 2026.

Charter / Spectrum may file any additional documentation to support its position.

Mr. Muniz and Charter / Spectrum's documentation are due on Friday, July 31, 2026.
