APPROVAL OF THE FOURTH AMENDMENT TO THE PENINSULA CLEAN ENERGY
AUTHORITY JOINT POWERS AUTHORITY (JPA) AGREEMENT (ACTION)

RESOLVED, by the Peninsula Clean Energy Authority of the County of San Mateo and the city of Los Banos, State of California, that

WHEREAS, Peninsula Clean Energy Authority (PCEA) was formed on February 29, 2016; and

WHEREAS, the founding document of PCEA was its Joint Powers Agreement (JPA); and

WHEREAS, the JPA has been amended on three prior occasions, March 28, 2019, October 22, 2020, and September 26, 2024; and

WHEREAS, in October 2025 the PCEA Board approved the name change of the Authority to WestLight Energy; and

WHEREAS, the individual jurisdictions of Peninsula Clean Energy have approved the amendment to paragraph 2.2 of the JPA thereby affirming the Authority's name change from Peninsula Clean Energy to WestLight Energy;

WHEREAS, the Fourth Amendment to the Joint Powers Agreement amends the document to reflect the name change and replaces, where applicable, the name Peninsula Clean Energy with WestLight Energy;

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board approves administrative updates reflecting the name change of the Joint Powers Authority from Peninsula Clean Energy to WestLight Energy. These updates are thus reflected in the Fourth Amended JPA Agreement.

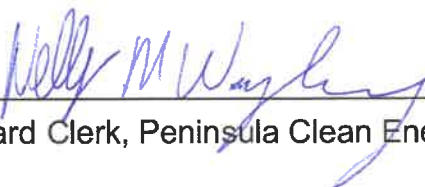

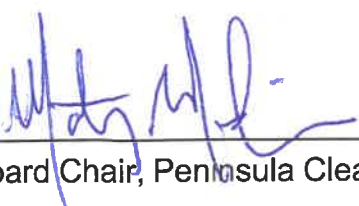
