On August 23, 2026, the Commission received a Petition for Modification (PFM), filed by Media Alliance, of Decision (D.) 26-08-033. Pursuant to the Rules of Practice and Procedure, responses are due in 30 days.

Pursuant to Rule 1.2, this ruling shortens the time to receive responses because the requested relief is limited in scope and the Commission already identified this internal inconsistency.
