To All Parties:

This email ruling schedules a remote status conference for Tuesday, September 1, at 1pm (Pacific). The purpose is to discuss the Motion to Adopt a Protective Order filed by TURN and CforAT on August 27, 2026. In addition to discussing the motion, we will discuss the alleged conduct contained in this motion.

The following parties are ordered to appear: AT&T, T-Mobile, Verizon, TURN and CforAT. Representatives of these parties shall be familiar with the discovery discussions amongst the parties. All other parties are welcome to attend the status conference.

Parties wishing to attend must send a procedural email to the assigned administrative law judge by noon on Monday, August 31. Parties are excused from needing to copy other parties for these emails. The assigned administrative law judge will email invitations to participate via WebEx.

Finally, by not later than noon on August 31, TURN and CforAT shall provide one document showing the discussions and items raised in their motion. The document should be organized by carrier and then be chronological in order, with the oldest communication or document first.
