**ADMINISTRATIVE LAW JUDGE'S RULING
SETTING WEBEX PREHEARING CONFERENCE**

Complainant Carson Reclamation Authority (Complainant) filed the instant complaint on June 26, 2026, alleging Defendant Southern California Edison Company (U338-E) (Defendant) has improperly failed to provide public utility service to a 157-acre former landfill site which is currently being redeveloped by the Carson Reclamation Authority. The site closed in 1965 for landfill use. Complainant alleges they have completed environmental remediation in compliance with all regulations.

Defendant filed their Answer and pending Motion to Dismiss on August 14, 2026. In their Answer, Defendant alleges that Complainant has filed improper and incomplete documentation sufficient to grant their application. They further allege in their pending Motion to Dismiss that the complaint is moot and unripe because Defendant has already agreed to provide utility service

to Complainant and their residents and should not be ordered or required to provide utility service to the former landfill site.
