**T-MOBILE WEST LLC'S STATEMENT OF CONFIDENTIALITY PER THE
PROTECTIVE ORDER**

In order to submit its Reply Comments on the Staff Proposal in the Commission's docket pursuant to the ALJ Glegola's August 19, 2026 Ruling Issuing Staff Proposal, T-Mobile West LLC dba T-Mobile (U-3056-C), on behalf of itself and its affiliates (collectively referred to as "T-Mobile"),¹ states that the confidential materials in these Reply Comments, including the Attachments, as marked, are submitted pursuant to the terms of the Protective Order adopted on September 2, 2026 which provides as follows in Paragraph 8:

8. Filings with the Commission. A party may in any document that it files in this proceeding disclose Confidential Information, and may attach Stamped Confidential Documents to such filing, only if it files the Confidential Information (and attachments) under seal. A party may make one Confidential filing, in addition to its public filings. The Confidential filing may be served on Outside Counsel or a Non-Carrier Party that signed the Acknowledgement. (Outside Counsel may redact the Confidential data and provide to inside counsel, who has signed appropriate Acknowledgment.) For purposes of this proceeding only, parties are relieved of the Rule 11.4 requirement to file a motion seeking confidential treatment for Confidential Information.

¹ T-Mobile West's affiliates include Assurance Wireless USA, L.P. dba Assurance Wireless (U-4327-C), MetroPCS California, LLC dba Metro by T-Mobile (U-3079-C), Mint Mobile, LLC dba Mint Mobile (U-4532-C), Sprint Spectrum LLC dba T-Mobile (U-3062-C) and UVNV, LLC dba Ultra Mobile (U-4441-C). All of these entities are separately registered wireless carriers that utilize the same network and are otherwise wholly owned subsidiaries of T-Mobile USA, Inc.

All information and materials marked as confidential in the Reply Comments, including all Attachments, are designated as Confidential Materials consistent with the terms, conditions and definitions in the Protective Order; no separate motion seeking confidential treatments of the Confidential Information is required per the Protective Order.
