BLUECASTLE IT SOLUTION'S RESPONSE TO ALJ'S SEPTEMBER 3, 2026, RULING.

Pursuant to the Administrative Law Judge's (ALJ) Ruling Setting Webex Prehearing Conference and Requiring BlueCastle IT Solutions, LLC to Attest to Information on the Service List and Provide Explanation for Non-Appearance, dated September 3, 2026 (Ruling), BlueCastle IT Solutions, LLC (BlueCastle) respectfully submits the following response.

1. Attestation Regarding Service List Information

Pursuant to Section 2 of the Ruling, BlueCastle hereby attests that the e-mail address for BlueCastle contained on the official service list on the Docket Card for this proceeding, dscott@bluecastleit.com, is true and correct.

2. Explanation for Non-Appearance at the August 27, 2026, Prehearing Conference

BlueCastle respectfully submits the following explanation for its failure to appear at the August 27, 2026, prehearing conference (PHC) in this proceeding.

BlueCastle received the ALJ's August 10, 2026, e-mail service of the Ruling Setting the Webex PHC. Upon review, BlueCastle understood the correspondence to be routine e-mail service of a procedural ruling and did not recognize that the ruling itself set a specific date and time for a hearing requiring BlueCastle's appearance. As a result, BlueCastle did not calendar the August 27, 2026, PHC and failed to appear.

This oversight was inadvertent and unintentional. BlueCastle has separately corresponded with Commission staff regarding hearing scheduling in this proceeding and at no time intended to disregard the Commission's authority or its obligations under the Commission's Rules of Practice and Procedure. BlueCastle regrets the error and any inconvenience it caused the Commission and other parties to this proceeding. BlueCastle has since implemented internal procedures to ensure that all Commission correspondence, including e-mail service of rulings and notices, is reviewed promptly and in full so that any hearing dates, deadlines, or required actions are identified and calendared.

BlueCastle appreciates the Commission's and the ALJ's attention to this matter and intends to fully comply with the Ruling and all further directives in this proceeding, including appearing at the Webex PHC now set for September 23, 2026.
