BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

Order Instituting Investigation on the Commission's own motion into the alleged failure of TracFone Wireless, Inc. (U-4231-C) to collect and remit public purpose program surcharges and user fees on revenue from its sale of intrastate telephone service to California consumers, in violation of the laws, rules and regulations of this State; Order to Show Cause why Respondent should not immediately be ordered to pay all such outstanding sums plus interest, and be subject to penalties for such violations.

ORDER EXTENDING STATUTORY DEADLINE

Summary

This decision extends the statutory deadline in this proceeding to August 19, 2013.

Background

Pub. Util. Code § 1701.2(d)¹ provides that adjudicatory matters, such as this proceeding, shall be resolved within 12 months after they are initiated, unless the Commission makes findings why that deadline cannot be met and

issues an order extending the 12-month deadline. Today's decision extends the statutory deadline until August 19, 2013.

This proceeding was filed on December 17, 2009. Delays occurred in processing this docket due to uncertainties caused by a pending application for rehearing by TracFone of Resolution T-17235 and the subsequent amendment of this Investigation by Decision (D.)10-05-021. To accommodate these delays, the statutory deadline was extended for 12 months, until December 17, 2011, by an Assigned Commissioner's Scoping Memo dated September 30, 2010.

This case has been divided into two phases.

A Presiding Officer's Decision on Phase 1 was issued on November 18, 2011. However, because it was not anticipated that the case would be resolved before December 17, 2011, the Commission issued a decision extending the statutory deadline an additional 12 months to December 17, 2012.

The Phase 1 decision issued on February 24, 2012. Phase 2 of the proceeding addresses similarly complex issues. Prehearing conferences were held on July 3, 2012 and September 18, 2012. The procedural schedule for Phase 2 was set to allow sufficient time for each party to prepare and present its case. Testimony was scheduled to be filed in September and November 2012, with evidentiary hearings scheduled for December 2012. In light of this procedural schedule, it is necessary to extend the statutory deadline to allow parties sufficient time for briefing and for a decision to be issued. To accommodate this, the statutory deadline should be extended an additional eight months, until August 19, 2013.

Waiver of Comments on Proposed Decision

Under Rule 14.6(c)(4) of the Rules of Practice and Procedure, the Commission may waive the otherwise applicable 30-day period for public

review and comment on a decision that extends the 12-month deadline set forth in § 1701.2(d). Under the circumstances of this case, it is appropriate to waive the 30-day period for public review and comment.

Assignment of Proceeding

Michel Peter Florio is the assigned Commissioner and Jeanne M. McKinney is the assigned Administrative Law Judge and Presiding Officer in this proceeding.

Findings of Fact

- 1. The Commission issued this Investigation on December 17, 2009.
- 2. The assigned Commissioner extended the statutory deadline applicable to this proceeding on September 30, 2010, for a 12-month period of time, until December 17, 2011.
- 3. The assigned Commissioner extended the statutory deadline applicable to this proceeding on December 20, 2011, for a 12-month period of time, until December 17, 2012.
- 4. An additional extension of time until August 19, 2013 is needed to continue to resolve this Investigation.

Conclusions of Law

It is reasonable to extend the statutory deadline for an additional eight months, until August 19, 2013, to allow for resolution of this proceeding as it will not be possible to resolve this case within the period of time provided for in Pub. Util. Code § 1701.2(d) as extended by the September 30, 2010 scoping memo and further extended by D.11-12-042.

ORDER

IT IS ORDERED that the 12-month statutory deadline in
