**R E S O L U T I O N**

RESOLUTION ALJ-362. Resolves proceeding K.19-02-011, the Appeal of Call America, Inc. (U6598C) from Citation CD-2019-01-028 issued by the Communications Division of the California Public Utilities Commission.

---

This Resolution resolves proceeding K.19-02-011, the Appeal of Call America, Inc. (U6598C) (Call America) from Citation CD-2019-01-028 issued by the Communications Division of the California Public Utilities Commission (CD). Call America withdrew its citation appeal. CD did not oppose the Call America withdrawal of its citation appeal.

The Commission regulates communication utilities. CD is authorized to issue citations to a communication utility for violation of the Public Utilities Code and/or Commission orders, pursuant to Resolution T-17601 and Resolution ALJ-299. In turn, a communications utility issued such a citation may accept the fine imposed or contest it through a process of appeal, pursuant to Resolution T-17601 and Resolution ALJ-299.

On January 11, 2019, CD issued Citation CD-2019-01-028 against Call America. Citation CD-2019-01-028 was based upon Call America's alleged failure to file submissions with the Commission that are mandated pursuant to Public Utilities Code Sections 702, 2101, 2107, and 2108, General Order 104-A, and Resolution T-17601. On February 5, 2019, Call America noticed its appeal of Citation CD-2019-01-028. On May 2, 2019, Call America submitted a written withdrawal of its citation appeal. CD did not oppose the Call America withdrawal of its citation appeal.

K.19-02-011 should be dismissed because, due to Call America's withdrawal of its citation appeal, there are no remaining issues for the Commission to resolve.

REGULATORY AUTHORITY

The Commission has authority to regulate communications utilities. Dismissal of this citation appeal due to the appellant's withdrawal of its appeal is consistent with the Commission's authority to ensure that communications utilities are meeting their regulatory obligations.

COMMENTS

No public review or comment is required for this Resolution pursuant to Rule 14.6(b).

**THEREFORE, IT IS ORDERED** that:

1. The Appeal of Call America, Inc. (U6598C) from Citation CD-2019-01-028 issued by the Communications Division of the California Public Utilities Commission is dismissed with prejudice.
2. This proceeding is closed.
