ORDER CORRECTING ERROR IN DECISION 18-10-008

The Commission has been informed of an editing error in Decision (D.)18-10-008, which addressed workforce requirements and third -party contract terms and conditions.

Pages 33 and 34 of D.18-10-008 discuss background checks required for contractor personnel with direct contact with utility or customer facilities, assets, or premises. The text specifically states that "employees of software companies working on programming or other products to support programs, where there is no access to individual customer premises, need not be subject to background checks at all." The required language on Page 34 reflects this determination.

The recitation of the adopted contract term in Appendix A, which is required by Ordering paragraph 6, however, inadvertently included an earlier

version of the proposed language, which failed to reflect the determination made within the text of the decision itself.

Therefore, the text in Appendix A, which appears on Page A-3, should remove the reference to customer "data or systems" and should be revised to read as follows, matching the approved language that appears on Page 34 of the decision:

2. Background Checks.

(a) Implementer hereby represents, warrants and certifies that any personnel of Implementer or Implementer Party, and their representatives and agents, having or requiring access to Company's assets, premises, or customer property, (Covered Personnel) shall have successfully passed background screening on each such individual, prior to receiving access, which screening may include, among other things to the extent applicable to the Services, a screening of the individual's educational background, employment history, valid driver's license, and court record for the seven year period immediately preceding the individuals' date of assignment to the project.

Therefore, pursuant to Resolution A-4661,

IT IS ORDERED that Decision 18-10-008 is corrected to reflect the following changes:

1. The third-party contract term associated with Background Checks, reflected on A-3 in Attachment A, shall read as follows:

2. Background Checks.

(a) Implementer hereby represents, warrants and certifies that any personnel of Implementer or Implementer Party, and their representatives and agents, having or requiring access to Company's assets, premises, or customer property, (Covered Personnel) shall have successfully passed background screening on each such individual, prior to receiving access, which screening may include, among other things to the extent applicable to the Services, a screening of the individual's educational background, employment history, valid driver's license, and court record for the seven year period immediately preceding the individuals' date of assignment to the project.

This order is effective today.
