- The approved revenue requirement results in \$1.14 million or a 1.43 percent higher Base Rate Revenue compared to present rates. When combined with all the other charges that Liberty Utilities is authorized to collect, the rate revenues will increase by 3.1% relative to present rates.
- The decision retains the current rate design and customer charge for all rate classes.
