#### EXECUTIVE DIRECTOR RESOLUTION

Resolution WSD-015. Executive Director Resolution Correcting Typographical and Inadvertent Errors in Resolution WSD-011

The Wildfire Safety Division (WSD) has identified several typographical and inadvertent errors in Resolution WSD-011. The errors occur in Attachment 2.2 to WSD-011, "2021 Wildfire Mitigation Plan Guidelines Template," and Attachment 2.3 to WSD-011, "Wildfire Mitigation Plan Quarterly report — non-spatial data template." The inadvertent errors identified by the WSD are as follows:

## **Attachment 2.2:**

- Section 7.3.2: Correct an obvious error in the numbering of a list of mitigation initiative activities; no change to the substance or wording of the activities. The numbering for mitigation initiative activities was incorrectly inputted as numbered 1 87 when it should have been numbered 7.3.1.1 through 7.3.10.4 to match the numbering system in WSD-001, Attachment 1 (2020). In Resolution WSD-001, initiatives were numbered 5.3.1.1 to 5.3.10.4.
- Section 7.3.2: Correct a typographical addition to make the Attachments to Resolution WSD-011 consistent. Remove capability 1.6 (weather-driven risk map and modeling based on various relevant weather scenarios) from Section 7.3.2 to align with removal of this item from the glossary (Section 9.1) and from Attachment 2.3, Table 12 of the excel spreadsheet.
- <u>Section 7.3:</u> Correct an obvious error in the numbering of subsections to be consistent with the correct numbering found in Attachment 2.3, Table 12 of the excel spreadsheet.

• <u>Section 9.1</u> Glossary: Correct a typographical error. The words "distribution" and "transmission" were inadvertently swapped in the definitions of four initiatives. For example, the name of an initiative was "...inspection of distribution lines..." but the definition referred to transmission lines.

# **Changes to Attachment 2.3:**

- Table 11, rows 22-24:
  - o Row 22: The "units" field was inadvertently written as "4.a./4.c." but should have been "4.c./4.a." to correspond to the name of the row titled "% of customers notified prior to a Public Safety Power Shutoff (PSPS) event impacting them."
  - Row 23: the "units" field was inadvertently written as "4.b./4.d."
    but should have been "4.d./4.b." to correspond to the name of the row titled "% of medical baseline customers notified prior to a PSPS event impacting them."
  - o Row 24: The phrase "Number of PSPS De-energizations" should have been "Number of PSPS events where de-energization did not occur" to correspond to the intent of the request, which is to track when a utility called a de-energization event but did not deenergize lines.
- <u>Table 12, Column D:</u> Correct an obvious error in the number of the list of mitigation initiatives to match the initiative numbering in the 2020 Wildfire Mitigation Plans (WMP), the errata for the 2021 WMP guidelines, and the numbering change requested for Section 7.3.2 above.
- <u>Table 1, row 60:</u> Correct a typographical error. The name of a metric was initially inadvertently written as "customer impact metrics" when it should have been "customer outreach metrics" to accurately describe the information being collected.

The corrections identified by WSD are inadvertent and typographical in nature. Therefore, pursuant to Resolution A-4661,

- 5. Rulemaking 18-10-007 remains open.
