- Establishes a working group to look at distribution-level solutions to anti-islanding and requires the development of an interconnection guidebook on anti-islanding;
- Allows future consideration of a pilot to test operational alternatives to address flexibility constraints; and
- Directs the development and finalization of a template aggregator agreement.
