(U4321C) (TracFone), América Móvil, S.A.B. de C.V. (América Móvil), and Verizon Communications, Inc. (Verizon) to transfer control of TracFone from América Móvil to Verizon, with conditions. CforAT originally requested \$225,883.00.
