In the Matter of the Application of California Water Service Company, a California corporation, for an order (1) authorizing it to increase rates for water service by \$80,484,801 or 11.1% in test year 2023, (2) authorizing it to increase rates on January 1, 2024 by \$43,582,644 or 5.4%, and (3) authorizing it to increase rates on January 1, 2025 by \$43,197,258 or 5.1% in accordance with the Rate Case Plan, and (4) adopting other related rulings and relief necessary to implement the Commission's ratemaking policies

### PROPOSED OUTCOME:

- Approves partial Settlement Agreement and adopts rates for California Water Service Company for 2023 general rate case.
- Closes the proceeding.

### ESTIMATED COST:

• The Proposed Decision adopts a Test Year 2023 revenue requirement of \$803,022,640, an increase of 10.8 percent compared to 2020, and a Test Year 2023 Rate Base value of \$619,940,847, representing a 41.3 percent increase over 2020.
