# RESOLUTION

RESOLUTION ALJ-471: Resolves K.24-05-003, the Appeal of ZTG Inc. U-6651-C to Citation No. CD-2024-02-031 issued by the Communication Division.

#### **SUMMARY**

This resolution resolves the appeal of Citation No. CD-2024-02-031 by the California Public Utilities Commission's (Commission's) Communication Division. Citation No. CD-2024-02-031 issues a fine of \$1,000.00 to ZTG Inc. (ZTG) for non-compliance with reporting and remitting surcharges and/or user fees.

Pursuant to Resolution T-17601, the Commission has the authority to require telephone corporations to report either intrastate revenue and/or access lines and remit Public Purpose Program surcharges and user fees (where applicable). Violations may include but are not limited to non-compliance with Public Utility Code Sections 247.1, 285, 702, 2101, 2107, 2108, and Decision 22-10-021.

#### **BACKGROUND**

Pursuant to California Public Utilities Commission (Commission) Resolution T-17601, and Public Utilities Code (Pub. Util.) Code Sections 247.1, 285, 702, 2101, 2107, 2108, and Decision 22-10-021, the Communications Division (CD) issued ZTG, Inc. a citation assessing \$1,000.00 for non-compliance in reporting and remitting surcharges and/or user fees.

Resolution T-17601 (Resolution) authorizes the CD Staff (Staff) to implement a citation program for enforcing compliance by telecommunications carriers with the Commission's Resolutions, Decisions, Orders, and the Public Utilities Code. The Resolution adopted a citation procedure, a list of specific violations, and the corresponding amount of each fine or penalty. Telephone corporations may accept the fine imposed or contest it through the process of appeal under Resolution ALJ-377.

Telephone corporations or carriers operating in California are required to comply with annual reporting requirements. Staff contacts carriers before reporting requirements are due. If carriers do not comply with the required reporting deadlines staff will send a citation to the address on record for that carrier.

## **DISCUSSION**

ZTG filed an appeal for Citation CD-2024-02-031 and the Commission granted the request. A virtual hearing was held on July 26, 2024. ZTG and CD appeared as parties at the hearing. Staff offered into evidence Exhibits numbered 1 through 12 as follows:

ZTG Inc. represented by Mr. Zandrelli introduced no exhibits at the July 26, 2024, hearing.

## **RESOLUTION OF THE APPEAL**

During the hearing, the CD witness reviewed exhibits showing that Staff had repeatedly communicated with Mr. Zandrelli to inform and alert him about reporting deadlines.<sup>2</sup> According to the CD witness, each month carriers have to report their business activity to the Commission through a database system.<sup>3</sup> During 2023 the database system changed from TUFFS to AccessLines due to Commission Decision (D.) 22-10-021. D.22-10-021 updated the underlying mechanism that each database uses to calculate carrier surcharges. The TUFFS mechanism was based on intrastate revenues and the new AccessLines database uses the number of access lines that a carrier uses to provide telecommunications services.

On August 2, 2023, Mr. Zandrelli sent an email to Staff asking for a link to the California State Agency Electronic Funds Transfer (EFT) payment system. On August 4, 2023, Staff responded to Mr. Zandrelli providing the link he requested.

On August 23, 2023, in response to an email from Mr. Zandrelli, Staff informed Mr. Zandrelli about the reporting frequency, monthly, and period covered by the legacy TUFFS system (October 2022 through March 2023). The August email also informed Mr. Zandrelli about the reporting changes covered from April 2023 and beyond indicating that, "if there are no intrastate revenue or access lines to report the Commission requires that "zero" be reported."<sup>4</sup> The email also clarified the ZTG Inc. would be "responsible for the User Fee, which has an annual minimum \$100.00 fee."

On October 3, 2023, and November 29, 2023, formal notices were sent to Mr. Zandrelli about non-compliance reporting for surcharges and/or user fees. Mr. Zandrelli contacted Staff on December 8, 2023, and on January 9, 2024, Staff sent Mr. Zandrelli an email<sup>5</sup> providing a link to the Legacy TUFFS system to enable him to complete

reporting covering the October 2022 through March 2023 period as well as a welcome email to the new AccessLines database for reporting for the April 2023 period onwards.

On February 7, 2024, Staff sent a citation to ZTG, Inc. The citation was sent electronically by email and by certified mail to the address on record for ZTG Inc. at that time, 3565 Del Rey Street, Ste 205, San Diego, CA 92109. During the hearing, Mr. Zandrelli clarified that the address above is not correct and ZTG Inc. has relocated to a new address. The new address, 199 Virginia Avenue, Suite No. 210, San Ysidro, CA 92173.6 Staff confirmed that it is ZTG Inc.'s responsibility to update us (the Commission) as to the latest contact information.<sup>7</sup>

During the hearing Mr. Zandrelli took full responsibility for filing late. He mentioned that post-COVID illness and prostrate issues. Mr. Zandrelli asked if the citation amount at \$1,000 be lowered and whether he can be offered a monthly payment plan similar to a previous citation that was paid in full successfully.<sup>8</sup> Unlike to previous citation, Mr. Zandrelli has no exhibits as evidence to verify his illness. In addition, as noted in the hearing transcript, "between the October 2023 notice of non-compliance to March 8<sup>th</sup>, we have about close to five months where the appellant could have become compliant without any penalty or fine from the citation."

Mr. Zandrelli is legally bound by the reporting requirements of the CPCN license; therefore, the citation is appropriate and cannot be reduced or dismissed. The appeal of ZTG Inc. of Citation CD-2024-02-031 issued on February 7, 2024, by the California Public Utilities Commission's Communications Division is denied.

## **COMMENTS**

The draft resolution was served on the parties for public review and comment in accordance with Public Utility Code Section 311(g)(1), Article 14 of the Commission's Rules of Practice and Procedure, and Rule 18 of Resolution ALJ-377. No comments were filed into the record of this proceeding.

## **FINDINGS AND CONCLUSIONS**

- 1. ZTG Inc. violated Resolution T-17601 by failing to submit its monthly reporter for surcharges and user fee.
- 2. CD issued a citation on February 7, 2023, with a penalty amount of \$1,000.00.
- 3. Mr. Zandrelli, the owner of ZTG Inc., admitted to being unable to respond to emails and certified mail.
- 4. Mr. Zandrelli, the owner of ZTG Inc., took full responsibility for filing late and being non-compliant with the reporting requirements prescribed by a CPCN license holder.

### **THEREFORE, IT IS ORDERED** that:

- 1. The Appeal of ZTG Inc. of Citation CD-2024-02-031 issued on February 7, 2024, by the California Public Utilities Commission's Communications Division is denied.
- 2. The violation and penalty set in Citation CD-2024-02-031 if affirmed.
- 3. ZTG Inc. must pay the penalty of \$1,000.00. Payment must be made by check or money order payable to the California Public Utilities Commission and mailed or delivered to the Commission's Fiscal Office at 505 Van Ness Avenue, San Francisco, CA 94102-3298. ZTG Inc. shall write on the face of the check or money order "For deposit to the California General Fund per Resolution ALJ-441."
- 4. Proceeding K2405003 is closed.
