ORDER GRANTING A PARTIAL STAY OF DECISION 25-08-035

This Order grants, in part, the motion for stay of Decision (D.) 25-08-035 (Decision) filed on September 29, 2025, by Lyft, Inc. (Lyft). The motion was filed concurrently with Lyft's application for rehearing of the Decision. In today's Order, we address only Lyft's motion for a stay.

Pursuant to Public Utilities Code section 1735, our authority to grant a stay is discretionary. We have preliminarily considered Lyft's arguments in support of a stay. On balance, to give our full consideration to Lyft's arguments and application for rehearing, we will grant a partial stay of the Decision at least until disposition of Lyft's application for rehearing. Our discretionary conclusion here does not predetermine our more thorough review of the pending application for rehearing or our decision thereon.

Because Lyft's application for rehearing challenges the Decision's conclusions and orders as to the 2021-2024 Annual Reports (and future compliance) only, Lyft's (and other Transportation Network Companies') obligations to comply with the Decision's Ordering Paragraphs 3 and 4 as to 2014-2020 Annual Reports remain unaffected and are not subject to stay.

THEREFORE, IT IS ORDERED that:

1. Lyft, Inc.'s motion for stay of D.25-08-035 is granted, in part.
2. D.25-08-035 is stayed as to the 2021-2024 Annual Reports and Annual Reports for 2025 and thereafter at least until disposition of Lyft, Inc.'s application for rehearing of D.25-08-035.
3. Ordering Paragraph 3 of D.25-08-035 as to the 2020 Annual Report is not stayed. All Transportation Network Companies subject to Ordering Paragraph 3 shall submit the 2020 Annual Report on November 13, 2025 pursuant to the schedule set forth in the ordering paragraph.
4. Ordering Paragraph 4 of D.25-08-035 as to the 2014-2019 Annual Reports is not stayed. All Transportation Network Companies subject to Ordering Paragraph 4 shall submit the 2014-2019 Annual Reports pursuant to the schedule set forth in the ordering paragraph as follows: 2019 Annual Report on November 27, 2025; 2018 Annual Report on December 11, 2025; 2017 Annual Report on December 25, 2025; 2016 Annual Report on January 8, 2026; 2015 Annual Report on January 22, 2026; and 2014 Annual Report on February 5, 2026.
5. This proceeding, Rulemaking 12-12-011, remains open.
This order is effective today.
