PROPOSED OUTCOME:

- Adopts a single electricity-based value to represent both electricity and natural gas greenhouse gas (GHG) values in the Avoided Cost Calculator (ACC) and removes the GHG rebalancing component.
- Adopts a simplified implementation of the Integrated Calculation for Generation Capacity and GHG Costs.
- Adopts loss of load hours rather than expected unserved energy for calculating ACC capacity allocation factors to measure the frequency of loss of load events.
- Uses energy prices rather than temperature to allocate generation capacity value to specific days of the year.
- Represents reliability risk differences of weekdays versus weekends in the ACC's capacity value allocation.
- Updates the peak capacity allocation factors calculations for transmission avoided costs to use the Integrated Energy Policy Report load forecast for future years, as used in the Strategic Energy & Risk Valuation Model modelling for calculating energy avoided costs, instead of historical loads.
- Uses the Discounted Total Investment Method approach to calculate marginal transmission costs for all electric utilities.
