Thank you for setting up a call to discuss the Hydrogen project.

SDGE is considering Hydrogen Electrolyzer at Palomar site, and looking to fuel-mix H2 into the 7F.04 turbine,

Our questions are:

- Considering 5% H2 by volume, is there any retrofit needed?
- What is the maximum H2 fuel mix without any retrofit?
- Is fuel mixer necessary for 5% mix?
- What are the impact on burning 5% H2 long term on our system? Is it quantifiable?
- How can GE help the project?
- Is there similar GE project we can reference?
