The draft resolution initiates Pub. Util. Code § 851 pilot program, as revised to reflect comments, and discusses next steps in improving the processing of § 851 applications.

The draft resolution will not appear on the Commission's agenda for at least 30 days after the date it is mailed. The Commission may act then, or it may postpone action until later.

When the Commission acts on the draft resolution, it may adopt all or part of it as written, amend or modify it, or set it aside and prepare its own resolution. Only when the Commission acts does the resolution become binding on the parties.

Parties may file comments on the draft resolution as provided in Article 19 of the Commission's Rules of Practice and Procedure (Rules), accessible on the Commission's website at [http://www.cpuc.ca.gov/PUBLISHED/RULES PRAC PROC/44887.htm](http://www.cpuc.ca.gov/PUBLISHED/RULES%20PROC/44887.htm). Pursuant to Rule 77.3, opening comments shall not exceed 15 pages.

Comments must be filed with the Commission's Docket Office. Comments should be served on parties whose names appear on the § 851 Project List¹ included here in accordance with Rules 2.3 and 2.3.1. Electronic copies of comments should be sent to ALJ Carew at lrc@cpuc.ca.gov and ALJ Allen at pva@cpuc.ca.gov. All parties must serve hard copies on the above ALJs, and for that purpose I suggest hand delivery, overnight mail or other expeditious methods of service.
