The CPUC will hold a public meeting, chaired by President Peevey, on the issue of climate change. The purpose of this meeting will be to move "beyond energy procurement" and to begin to identify best practices for all CPUC regulated companies (electric, natural gas, telecommunications, water, and transportation). Opportunities to reduce greenhouse gas

emissions related to business operations include fleet vehicle efficiency, building efficiencies, and overall reduction of energy consumption. The U.S. is the world's largest greenhouse gas emitter and is responsible for approximately 25% of the world's emissions. California policymakers and businesses have the opportunity to proactively address this issue, to demonstrate effective leadership, and to make a significant contribution to emissions reduction. Invited presenters include representatives from the academic, research, business, insurance, shareholder activist, and state government organizations. Business and industry leaders will also be asked to respond to a recent CPUC summary paper on the subject. In addition, the IOUs should be prepared to present their current and anticipated efforts to address climate change. Robinson discussed generally the issues that resulted in Verizon's filing the petition to modify with an emphasis on the revised draft decision (RDD) which adopts a significantly reduced common cost mark-up. Robinson also shared that common cost issues are currently being debated in Verizon's permanent UNE proceeding, and that any concerns about the Ninth Circuit Court's decision regarding SBC's common cost mark-up should be addressed there. Robinson also discussed the implications of the Federal Communications Commission's press release and anticipated UNE-P price increases.
