Also present were Larry Chaset, advisor to Cmmr. Grueneich, Brian Prusnek, advisor to Cmmr. Kennedy, and Dennis Keane, Manager, Service Analysis, for PG&E. Written material (attached to the notice) was used. Eisenman explained that the goal of PG&E and other utilities in Phase 2 of the proceeding is that no costs be shifted to bundled customers, that Resource Adequacy not be compromised, and that the Commission continue to have jurisdiction over Community Choice Aggregations (CCAs). Eisenman advocated that PG&E should not be relieved of its Resource Adequacy responsibilities until a CCA commits to a firm date for supplying energy to its customers.
