**ADMINISTRATIVE LAW JUDGE'S RULING
FOR ADDITIONAL INFORMATION AT THE
PREHEARING CONFERENCE**

Smurfit Stone Container Corporation (SSCC) and Southern California Edison Company (SCE) shall provide additional information at the August 29, 2001 Prehearing Conference. This additional information shall include:

- A. An organization chart that depicts the ownership and relationship of SSCC with each of its affiliates and subsidiaries.
- B. The billing and payment terms and conditions set forth in the June 7, 1985, Vernon Qualifying Facility contract, and identification of parties that entered into such contract.
- C. SCE's tariffs applicable to its customers' electric billing and payment terms and conditions.

- D. The correction and completion of the attached Appendix A Table that identifies the billing account numbers, customer's name, and amounts SSCC has on deposit with the Commission.
